Governance Structure

ADA Annual Conference usually takes place once a year in January or February to assess the results of yearly activities and make strategic plans.

ADA Steering Committee (SC) is responsible for providing collective leadership and direction on behalf of all members. It is composed of 6 member organizations, 2 from each sub-region, namely South Asia, Southeast Asia and Northeast Asia with a mandate of two years.

Coordination Committee (Co-Co) is composed of 3 Co-conveners among the 6 SC members. The Co-Co is responsible for facilitation and coordination of the decisions-making and implementation of the decisions on behalf of the SC.

ADA Working Groups

The Working Group(WG) is composed of ADA members and regional CSOs that have thematic expertise and led by two Co-Chairs. Some Working Groups are in the process of being formed.

The GALAA

Glo-cal (Global and Local) Advocacy Leadership in Asia (GALA) Academy

is an advocacy training program that is a joint initiative with the Asia Democracy Network(ADN) and Asian Forum for Human Rights and Development (FORUM-ASIA) to strengthen cooperation and mutual mainstreaming among development, democracy and human rights movement in the context of implementation of UN 2030 Agenda for Sustainable Development, in particular Sustainable Development Goals (SDGs). It started in 2013 and usually takes place in Bangkok for one week in August every year.
